What tariffs does Poland have?

Poland adheres to the General Agreement on Tariffs and Trade (GATT) and tariffs are based on the Harmonised System. Polish customs regulations comply with the European Union's European-wide directives. The majority of goods are subject to tariffs rates of up to 30 per cent, although tariffs on some luxury items are more than 100 per cent.

What are the tariffs imposed by Poland in 2022?

Tariffs imposed by Poland in 2022 are below. The maximum rate of tariff in percentage on any product is 175.99. The simple average tariff across all products is 2.03. The trade weighted average tariff is 1.79. The total duty free imports in thousands of US dollars are 99,848,519.64 and duty free tariff line items share is 67.75.
